



**Minutes of the Evaluation Committee for the incorporation a Researcher to the project  
“Modelling and Optimization of Gas transport networks”  
(ITMATI-OT-02/2020)**

The Evaluation Committee (EC) for the ITMATI-OT-02/2020 position is composed by:

- Mr. Alfredo Bermúdez de Castro (President of the Committee).
