Minutes of the Evaluation Committee for the incorporation of a researcher for SisAl Pilot project. (ITMATI-OT-11-2020)

The SisAl Pilot project has received funding from the European Union's Horizon 2020 research and innovation programme under grant agreement No 869268.

The Evaluation Committee (EC) for the ITMATI-OT-11-2020 position is composed by:

After reviewing all the documentation of each of the 10 candidates who applied for the position, based on the criteria established by the call, the members of EC decided unanimously to propose 2 candidates for the personal interview phase, which reached at least 35 points in the previous sections established by the call.

The interviews were held on November 12, 2020 between 1:00 p.m. and 2:30 p.m.

The EC met after the interview phase on November 19, 2020, chaired by Prof. Dr. Alfredo Bermúdez de Castro and with the assistance of all its members. Based on the criteria established by the call, the EC unanimously decides to vacate the position offered since none of the candidates presented meets the requirements established in the call. Particularly, none of the candidates accredits sufficient experience and knowledge for the job in the following aspects: knowledge of mathematical models in electromagnetism and chemical reactions, previous experience in the use of numerical simulation for electromagnetism problems, previous professional experience related to the project theme.
